2. **Apologies** were received from , Trevor long, Jenni Bertram,
3. **The minutes** of April 18^h 2011 were examined and accepted as a true record. These were proposed by Nigel LeFroy and seconded by Jimmy Green.
4. **Matters Arising**

Dinton Parish now had a link to the WILCAP website.

5. **Public Questions/Observations.**

Mr McClane had noticed from the WILCAP flyer that speeding within the Community Area had been raised as an issue . He made the observation that there was currently no format for individuals to follow up speeding issues within their community.

It was noted that sometimes there was a clear perception that vehicles were speeding but without proof this was virtually impossible to take any further.

Mr McClane emphasized the difficulty that some residents at the top end of Shaftesbury Road were still experiencing regarding the judgement of the speed of vehicles as they tried to enter or exit their drives. It was thought there might be a possibility of SID devices being purchased by communities within the partnership, with funding from the Area Board. It was also thought that these devices could then be moved around the communities at regular intervals, as they tend to loose any effect they might have on speeding if they are left in the same place for too long.

6. **Wilton Eco Project.**

Suzanne Butters gave an update on the current situation with regard to the proposed Eco Project for the former Land Command site. John Glen was in communication with the MOD who are hoping to market the site in July.

There could be a link to a viable community sports facility within this project and it was felt that this idea would be worth some serious exploration.

Charles Smith proposed that WILCAP support the Eco Project, this was seconded by Nigel LeFroy. The proposal was fully supported by all the members of WILCAP

7. **Andrew Jacks Community Profile Data.**

Some members had briefly looked at the data supplied by Andrew Jacks. Clive outlined a few of the Community health issues that he had identified from the data. Members felt that they needed to look at the Data in more detail. It was agreed that this would be a main agenda item for the next meeting and members were asked to be prepared for this. It was hoped that an identified Health Issue might be linked to the Eco Project if this was appropriate.
