Temporary Closure of: Various Roads, Fovant, Compton Chamberlayne, Mere and Maiden Bradley

Temporary Suspension of Existing 7.5 Tonne Weight Restriction: B3089 East Knoyle (A350 To A303 Willoughby Hedge) Westbound Only

(Ref: A2/DAH/NW/RC 2012/28)

Notice is hereby given that Wiltshire Council has made an Order to close temporarily to all traffic the following roads:

- (a) C64 High Street/Dinton Road, Fovant; from its junction with A30 in a north westerly direction to a point at the northern terminal of 30mph Speed Restriction (adjacent Leatler Close).

Alternative route via: A30 (Fovant – Barford St Martin), B3089 (Barford St Martin – Dinton), C64 (Dinton – Fovant) and vice versa.

- (b) C338 High Street/Horse Shoe Lane, Compton Chamberlayne and Dinton; from its junction with A30 to its junction with B3089 Dinton.

Alternative route via: A30 (Compton Chamberlayne to Barford St Martin), B3089 (Barford St Martin to C388 junction B3089) and vice versa.

- (c) C59 Pettridge Lane/Edge Bridge/Clements Lane/Shafesbury Road (Part), Mere; from its junction with Footpath 64 Dark Lane, Mere in a south easterly direction to its junction with UC 823101 (Limpers Hill Road).

Alternative route via: B3095 (Mere), B3095/B3092 (Mere – Gillingham), C74 Bay Road Gillingham to Lawn X-Roads) Dorset, C16 (Lawn X-Roads to Wiltshire Boundary), C59 (Wiltshire – UC 823101 Limpers Hill) and vice versa.

- (d) C303 Southbrook, Mere; from its junction with C59 Shafesbury Road in an easterly direction to its junction with UC 823101 Limpers Hill.

Alternative route via: C59 (Shafesbury Road to B3095 The Square), B3095 (Salisbury Street – A303), A303 Trunk Road, C303 (Burton junction to Limpers Hill) and vice versa.

- (e) B3092 (Part) Church Street/Frome Road, Maiden Bradley; from its junction with C25 Kingston Lane in a northerly direction to Somerset County Boundary.

Alternative route northbound vehicles via: A303 (Eastbound to A350 Furze Hedge), A350 (Furze Hedge to A36 Warminster), A36 (Warminster Bypass), A36 (Bath Road to A361 Beckington Roundabout Somerset), A361 (Beckington/Frome Bypass to B3092), B3092 (Somerset to Wiltshire Boundary).

Alternative route southbound vehicles via: A361 (Frome/Beckington Bypass), A36 (Bath Road, Warminster Bypass), A350 (Warminster to B3089 Stagger X-roads East Knoyle), B3089 (A350 to Willoughby Hedge), A303 (Willoughby Hedge to B3092 Zeals).

And to:

- (f) Temporary Suspend Existing 7.5 Tonne Weight Restriction Order on B3089 East Knoyle; from a point 135 metres west of its junction with A350 to a point 175 metres east of its junction with A303 at Willoughby Hedge to facilitate southbound diversion as described in (e) above.

To enable:

Wiltshire Council to carry out carriageway patching and storm water drainage surveying.

This Order will come into force on Tuesday 1 May 2012 however it is anticipated that works will commence Tuesday 8 May 2012, and each closure will take between 1 & 3 days to complete, current program being closure (a) 18 May, (b) 18 May, (c) 8 – 10 May, (d) 11 – 14 May, (e) 21 – 22 May 2012. As works are weather dependant information boards displaying notification of dates will be erected on site.

This Order will be re-enacted at a later date to be notified in order to carry out final carriageway resurfacing, replacement of road markings and road stud replacement. The Order will have a maximum duration of 18 months.
